

**Parental Instructions and Activities Non-Consent Form**

Per the rights given me in [Texas Education Code Chapter 26](#) *Parental Rights and Responsibilities* and specifically Section 26.010 which states the following:

“Sec. 26.010. EXEMPTION FROM INSTRUCTION. (a) A parent is entitled to remove the parent's child temporarily from a class or other school activity that conflicts with the parent's religious or moral beliefs if the parent presents or delivers to the teacher of the parent's child a written statement authorizing the removal of the child from the class or other school activity.”

I, \_\_\_\_\_, as parent and/or legal guardian of \_\_\_\_\_, a minor child, hereby exercise my rights stated above and duly place school administrators and staff on notice of the following:

**Section 1**

I DO NOT CONSENT to my child's participation in any instruction, discussion, or activity which is derived in whole or in part from, contains information from, or references to the following sources:

- National Sexuality Education Standards
- Sex, Etc.
- Advocates for Youth/Amaze
- Answer
- SIECUS (Sexuality Information and Education Council of the U.S.)
- Planned Parenthood
- The Kinsey Institute
- GLSEN (Gay Lesbian Straight Education Network)
- GSA (Gender & Sexuality Alliance, previously known as the Gay Straight Alliance)
- TeenSource
- 1619 Project
- A People's History of the United States - Howard Zinn

**Section 2**

I DO NOT CONSENT to my child being given instruction or information on or being subjected to discussion or activities of any of the following:

1. Abortion;
2. Birth Control/Contraceptives;
3. Sexual activity of any kind including but not limited to vaginal, oral, or anal sex, and masturbation;

4. Sexual orientation including but not limited to any variant of homosexuality including but not limited to lesbian, gay, bisexual, queer, or questioning identities;
5. Gender identity, including, but not limited to transgenderism, gender as social construct, gender binary, gender spectrum, gender reassignment surgery, gender dysphoria, preferred gender pronouns, gender expression, puberty-suppressing hormones, cross-sex hormones, methods or surgeries to alter appearances attributed to biological sex;
6. Child abuse, family violence, dating violence, and sex trafficking;
7. Any referral of my child to a counselor, medical professional, social worker, within or outside the school for purposes of discussing sexuality or any of the topics listed herein;
8. Any written material of, reference to, or referral to an outside agency, group, individual or organization relating to sexuality including but not limited to those listed in this document;
9. Any advertisement by or participation in any group, organization, club, entity or activity that discusses or addresses sexual activity, sexual orientation or gender identity under the guise of anti-bullying, Social and Emotional Learning, or any other rationale;
10. Any performance by or activity with drag queens, drag kings, or other cross-sex impersonators;
11. Any additional instruction and discussion or activity including but not limited to classroom teachers, school staff, counselors, librarians, third-providers, YouTube or other videos, films, live streaming, other audio-visual methods, textbooks, workbooks, or handout material including any entity listed under Section 1 and/or any topic listed under Section 2.
12. Any instruction or materials teaching or promoting 1619 Project; Howard Zinn; Diversity, Equity, and Inclusion; Critical Race Theories as listed in TEC28.0022(4)(i-viii).
13. Any instruction, materials or inclusion of any program that promotes the belief systems of "Restorative Justice" as detailed in AISD's "Culturally Restorative Practices" Model, Social Emotional Learning, or any other program that promotes explicit or tacit spiritual beliefs and methodologies (i.e., "oneness," "mindfulness," "meditation").

I request alternative academic instruction for my child be given alternative instruction during the time that these materials and subjects are being presented.

### **Section 3**

Per the parental rights and student protections guaranteed by Texas law and under the federal Family Educational Rights and Privacy Act (FERPA) and Pupil Rights Protection Act (PRPA) and as stated in district policy EF(LEGAL), I must be notified and allowed to view any and all surveys that will be given to my child including but not limited to those that ask questions regarding the following:

1. political affiliations or beliefs of the student or the student's parent;
2. mental and psychological problems of the student or the student's family;
3. sex behavior or attitudes;
4. illegal, anti-social, self-incriminating, or demeaning behavior;
5. critical appraisals of other individuals with whom respondents have close family relationships;
6. legally recognized privileged or analogous relationships, such as those of lawyers, physicians, and ministers;

- 7. religious practices, affiliations, or beliefs of the student or student’s parent; or
- 8. income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such program).

**Section 4**

As required by [TEC Sec. 26.009](#) I DO NOT CONSENT for any employee of the school district to conduct any psychological examination, test, or treatment, unless the examination, test, or treatment is required under Section [38.004](#) or state or federal law regarding requirements for special education. I DO NOT CONSENT to any assessments or questioning of the psychological, emotional, or spiritual condition of my child by any method or rationale including Social and Emotional Learning.

I hereby request that this notification be placed in my child’s permanent file and be provided to all people offering instruction to my child during the school year including teachers, aides, counselors, and librarians. Any instruction contrary to this notice will be the subject of further action to uphold my parental rights to protect and direct the education of my child.
